Haire – Just one item I want to highlight. Our intention is to have the DORA up and operating on January 13<sup>th</sup>. We're still awaiting the arrival of some trash cans. We've got to get signage up still which has been delayed due to the winter weather we've had. Those will be going up here either later this week or early next week. We've got flyers that'll be going out for all the businesses where they can request a sticker if they will not permit DORA beverages within their businesses. That's each business owner's right in the DORA area but we should be ready to go for that weekend of January the 13th.

Clark – Do you have any indication how many businesses are going to participate?

Haire – All of the liquor permit holders either have received or will be receiving shortly their notification from the State of Ohio that they have the endorsement for the Designated Outdoor Refreshment Area on their license. Those six liquor permit providers can participate in the DORA.

Clark – I was just wondering how many bars are going to participate.

Haire – They all have the ability to do so and there's no special cups. The providers I've talked to they all are thankful that there's not additional cups that they have to manage. They seem to be pleased.

Shea – Thanks for making that a reality in Canal Winchester. I know you and the mayor worked on it long and hard.

Amos — The corner of Winchester Pike and Brice Road, the apartment complex that's going in, I had a resident ask why we didn't pursue that corner. If I remember correctly, they went straight to Columbus. That was never an opportunity put in front of us to consider.

Haire – In that area we have utility capacity based on the elevations that are there. We can only serve so far to the North and so without significant sanitary sewer infrastructure we wouldn't be able to serve further North than Winchester Pike.

Amos – Do you remember how many units it is? It looks like it's over 200.

Haire – There's 500 plus on the corner there. I don't recall specifically that number but it's more than 500. They're working through the zoning process. I've only seen the plans associated with the traffic study where they saw input from Canal Winchester on the traffic study parameters because we have the southern boundary of the right-of-way there on Winchester Pike.

Amos – And they were not asked to put any money towards the Bixby interchange?

Haire — They're still working through the zoning process. I assume that they will be requested to do that based on the traffic engineer's initial feedback on that. They're coordinating with Franklin County Engineer's Office and with us on the access points. There's 10 access points proposed for the development as they initially proposed it on both Winchester Pike and Brice Road. That's an extreme number of access points for a parcel that size. We had some concerns with that and relayed those concerns.

Amos – At capacity you're looking at 1,200 to 1,400 cars.

Haire – The Columbus Development Commission did recently approve the rezoning for 900 plus units on Brice Road to the rear of World Harvest. It'll be multi-family and single-family.

Amos – I hope they each have to contribute. That's my hopes. Is there anything that we need to do to ensure that these developments are putting into that Bixby interchange?

Haire – You can always comment on the rezoning cases as they come up.

Clark – What kind of requirements are being made on the warehouse that's going in next to Wyler's?

Haire – They had a contribution amount that's required.

Walker – This is from Aletha Mullins. It was a busy year for us. Here are some of the stats from 2022 calendar. Unfortunately, we do not have the reports done from other programs, but updates will be coming on quarterly reports. The Food Pantry served 4,673 people, provided 62,659 meals, and 82,294 pounds of food went out of the building. Volunteer hours in the Food Pantry were 1,122 hours. The donation box consisted of 10,373 items. October through December, the Food Pantry meals were 2,246. 1,823 people, serving 19,909 meals and 32,467 pounds of food. 25% of the residents used our Market Day services from David's Way Canal Winchester. It was a 5% increase from last quarter. Human Services is getting ready for the biggest fundraiser, SOUPer Bowl XII. If anyone is interested in putting together a nice, themed gift basket or whip up some baked goods for the bake sale, we'd like to have them. It will be on Sunday February 12<sup>th</sup> from 11:00 a.m. to 2:00 p.m.
