



## Golf Cart Inspection - Checklist

*\*THERE IS A \$25 FEE PAYABLE TO THE CITY OF CANAL WINCHESTER THAT MUST BE PAID BEFORE YOU CALL THE SHERIFF'S OFFICE FOR GOLF CART INSPECTION. PAY BY CHECK, CARD, OR EXACT CASH (City of Canal Winchester Administrative Code, Chapter 143.01; Traffic Code, Chapter 333.04)*

\_\_\_\_\_ Requires a valid driver's license for ANY operation of a MOTOR VEHICLE on public or private property.

\_\_\_\_\_ Must show proof of insurance listing State Minimum Requirements for Liability Insurance for said Golf Cart.

\_\_\_\_\_ Must be equipped with a minimum of one tail light, visible from a distance of 500 feet.

\_\_\_\_\_ Must be equipped with two red reflectors. (May be incorporated into other rear lights.)

\_\_\_\_\_ Must have a light to illuminate the rear license plate & make the plate legible from a distance of 50 feet.

\_\_\_\_\_ Must be equipped with two brake lights, visible from a distance of 500 feet. (May be incorporated into other rear lights.)

\_\_\_\_\_ Must have two working headlights capable of illuminating persons or objects at a distance of at least 75 feet.

\_\_\_\_\_ Must have a working horn, audible from not less than 200 feet.

\_\_\_\_\_ Must have a rear-view mirror.

\_\_\_\_\_ Must have a windshield. (glass or safety glass)

\_\_\_\_\_ Must have working directional (turn) signals.

\_\_\_\_\_ Must have brackets for mounting two license plates (front & rear)

Once ALL items are complete, you can call Fairfield County Sheriff's Office at 740-652-7900 ext.3311 or 614-837-7913. *\*Payment of fee will be verified prior to inspection*

### **PLEASE NOTE:**

- **Golf Carts cannot be driven or operated on streets over 25mph (may cross over with due regard to traffic)**
- **Golf Carts cannot be driven on the bike path**
