2. All attachments, exhibits and conditions attached to this permit are hereby made a part of this agreement.
3. The applicant hereby enters into an agreement to maintain such street, alley, sidewalk, right of way, or easement in accordance with the current standards and specifications of the City, to provide adequate protective safe guards and to maintain the area free from debris, dirt and litter.
4. Any pavement, utility, landscape or appurtenance damaged within the Right of Way shall be immediately reported to the City and repaired to the City's satisfaction and no cost to the City.
5. The City reserves the right to require field adjustments of the proposed improvement at the time of installation.
6. An indemnity agreement may be required with the Special Right of Way Permit application. Such agreement provides that the applicant will hold the City of Canal Winchester and its officials and employees harmless of all liability which might arise as a result of accidents, injuries or damages suffered within the public right of way or as a result of the use of the right-of-way as authorized by this section, and to fully indemnify the City of Canal Winchester, its officials and employees, in the event the City is required to pay such losses.
7. Action taken pursuant to this permit shall be deemed acceptance of its terms and conditions including all requirements required by the Codified Ordinances of the City of Canal Winchester, Part 11, Title 7, Chapter 1197, Right of Way Use.
